

Technical Bids Evaluation Report

Pak-Austria Fachhochschule: Institute of Applied Sciences and Technology (PAF-IAST), Haripur invited sealed bids from interested firms for the Tender No. PAF-IAST/IT/2021/ Online Test & Examination advertised on April 24th, 2021 in national dailies for the “Cloud-based Online Tests and Examination System”, based on KPPRA Rule 6(2)(b) “Single stage, Two Envelop” with bid submission date as 20th May, 2021.

The four (04) bidders offered their Bid proposals among them, ELeads Solutions Pvt. Ltd did not submitted Bank Draft / Pay Order of Rs. 300/- which was the tender documents submission requirement. Further, this office has made communication for confirmation but till no response has been received.

Remaining three (03) bids were opened on the same time i.e., 20th May, 2021 at 12:30 PM by the Procurement Committee in presence of representatives of participating bidders.

- i. IT Heritages Pvt. Ltd.
- ii. DataHawk Enterprises (SMC-Pvt) Ltd.
- iii. Unified Communication Solutions

The Technical evaluation criteria comprised of four stages, including the presentation on the quoted solution. As per, evaluation criteria, presentation on the quoted solution from all three (03) participating bidders were scheduled and held on 27th May, 2021 before the Technical Committee, but Unified Communication Solutions was found absent.

After going through the bid proposals, the presentation from the participating bidders, and the clarification sought from the bidder during the presentation session, following is the assessment of the Technical Committee about each of the participating bidders.

Recommendations:

As per Technical Evaluation criteria defined in the tender document/RFP, and as stipulated therein the Technical qualification was to be based on both eligibility (bidder required to fulfill all conditions), as well as qualification on score basis (i.e., bidder are required to secure at least 70 percent to qualify). Therefore, the Technical Committee declared M/s IT Heritages (Pvt) Ltd. as responsive and qualified bidder on technical basis having met the defined criteria, and recommended to consider him for next step, i.e. opening of their financial proposal; whereas, M/s DataHawak Enterprises (SMC-Pvt) Ltd, and Unified Communication Solutions are declared as non-responsive and not qualified on technical basis, by the Technical Committee.
