

**Technical evaluation of tender for Supply of Bio-Medical Sciences Lab Equipment
LOT # 16 Incineration Chamber**

In compliance with the Rule 6 (2)(b) "Single Stage, Two Envelope Procedure" laid down in Khyber Pakhtunkhwa Public Procurement Regulatory Authority (KPPRA) Rules -2014, a tender (PAF:IAST-BMS-ITB-106-21) was published for the "Supply of Bio-Medical Sciences' Lab Equipment." Accordingly, the Tender was opened on 05-08-2021. The Tender was categorized into 17 Lots, and a total of six (06) bidders submitted bids for **Lot No. 16** i.e i) M/s Pak Glorious Enterprise; ii) M/s Human Healthcare; iii) M/s Spectrum Technologies; iv) M/s Med Engineering; v) M/s Mediland Pak Pvt. Ltd.; vi) M/s Abid Rafique & Co.

Lot #:16. Incineration Chamber

The technical committee thoroughly evaluated all the bids and five (05) bidders i.e. M/s Pak Glorious Enterprise, M/s Human HealthCare, M/s Spectrum Technologies, M/s Med Engineering and M/s Mediland Pak Pvt. Ltd were found eligible according to minimum eligibility criteria of Tender document. Abid Rafique and Co. did not provide minimum bid documents and hence were ineligible, whereas, Pak Glorious Enterprises, Spectrum Technologies and Med Engineering could not secure the minimum qualification score (70%) and hence stand disqualified.

The two bidders M/s Human Health Care and M/s Mediland Pak Pvt Ltd were found complying to the technical specifications as per tender document.

Recommendations:

It is therefore recommended to the procurement committee that the financial offer of the said bidder, i.e. M/s Human Healthcare and M/s Mediland Pak Pvt. Ltd may be opened. Furthermore, the financial offers/ bids of the bidders who could not qualify technically, may be returned unopened to respective bidders.
