Reference No. PAF: IAST-RLE-ITB-111-21 tender was advertised on June 26, 2021 in national dailies (F/I) for the "Supply of Research Lab Equipment". The Tender was advertised based on KPPRA Rule 6(2)(b) "Single Stage – Two Envelope". However, as per Clause 27 & 28 of Tender document/ RFP, there were Preliminary Examination and Evaluation of Eligibility and Technical Qualification which were defined in Section 4: Evaluation Criteria. Four (04) bids received in response to "Tender for Research Lab Equipment" were evaluated. The two bidders i.e. AMS and Technology Links were found eligible according to basic eligibility criteria of Tender document. Two bidders i.e., Kamstec International and Abid Rafiq & Company were found ineligible due to the deficiencies such as no information is provided about Customers' satisfaction certificate and no information is provided about relevant experience. Furthermore, Kamstec international and Abid Rafiq & Company could not secure the minimum qualification score (70%).

The two bidders (AMS and Technology links) were found to meet the technical specifications as per tender document.
