Recommendations:

As per Evaluation criteria defined in the tender document, and as stipulated therein the qualification was to be based on both eligibility (bidder required to fulfill all conditions), as well as qualification on score basis (i.e., bidder are required to secure at least 49 percent to qualify). Therefore, based on assessment of Technical Committee, M/s Pakistan Traders could not qualify as per preliminary examination, eligibility and qualification criteria and therefore declared not qualified for this Lot.

It is therefore recommended that the financial offer of M/s Pakistan Telecommunication Company Limited may be opened.
